Remarks (if any):

On 4 October 2019, the Company entered into a sale and purchase agreement with the Vendor to acquire 100% equity interest of the Target Group at the consideration of HK\$60,000,000, which was satisfied by (i) HK\$5 million by cash; (ii) the issue and allotment of 63,000,000 Consideration Shares at the Issue Price of HK\$0.28 per Consideration Share by the Company to the Vendor and (iii) the remaining amount of HK\$37.36 million by the issue of the Promissory Note by the Purchaser to the Vendor upon Completion. The Acquisition was completed on 3 January 2020. Details of the Acquisition were set out in the Company's announcement dated 4 October 2019, 29 November 2019 and 3 January 2020 and Company's circular dated 5 December 2019.
