VOLUNTARY ANNOUNCEMENT IN RELATION TO SALES AGENCY AGREEMENT WITH CAMBODIA CHIN WAY INVESTMENT CO., LIMITED

This announcement is made by PALINDA GROUP HOLDINGS LIMITED (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis to inform its shareholders and potential investors of the latest information about the Group.

The board of directors (“**Directors**”) of the Company (the “**Board**”) is pleased to announce that on 26 May 2023, Palinda Wines (H.K.) Limited (“**Palinda Wines**”) (an indirect wholly owned subsidiary with limited liability of the Company) and Cambodia Chin Way Investment Co., Limited (柬埔寨駿威投資控股有限公司) (“**Cambodia Chin Way**”) entered into a sales agency agreement (the “**Agency Agreement**”), pursuant to which Cambodia Chin Way has agreed to purchase and distribute the Group’s grape wines in the Cambodia market, which will provide an opportunity for the Group’s premium wine products to successfully enter the Cambodia market.

Cambodia Chin Way is a company established in Cambodia under the laws of Cambodia and is principally engaged in investment in real estate, hotels, supermarkets, import and export trade in Cambodia. The Group believes that this sales agency agreement with Cambodia Chin Way will be one of the important milestones for the Group’s market expansion in the grape wine market of Cambodia.

The Group is actively expanding its markets, such as, by developing sales networks and agents in different regions and making multiple sales through new retail formats, it has been offering premium grape wines to enthusiasts of grape wines in the Asia Pacific region and around the world. The Group also believes that the Cambodia market will have a positive and favourable impact on the Group’s results in the near future.
