**SUPPLEMENTAL ANNOUNCEMENT
ON INSIDE INFORMATION
APPOINTMENT OF RECEIVER
OVER CERTAIN SUBSIDIARIES OF THE COMPANY**

Reference is made to the announcements of Palinda Group Holdings Limited (the “**Company**”) dated 8 December 2025 and 23 January 2026 in relation to the Inside Information Appointment Of Receiver over certain subsidiaries of the Company (the “**Announcements**”). Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as defined in the Announcements. In addition to the information disclosed in the Announcements, the Board would like to provide the Shareholders and potential investors of the Company and its subsidiaries (the “**Group**”) with additional information on the Inside Information Appointment Of Receiver as follows:

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders and potential investors of the Company that Shanghai Commercial Bank Limited (the “**Plaintiff**”) has commenced legal proceedings against, among others, (i) Palinda Wines (H.K.) Limited, a wholly-owned subsidiary of the Company, as 1st defendant; and (ii) Palinda Group Holdings Limited (the Company) as 2nd defendant, in the High Court of the Hong Kong Special Administrative Region (the “**High Court**”).

According to a sealed copy of the Writ of Summons issued by the High Court on 23 February 2026 in High Court Action No. 331 of 2026 (the “**Proceedings**”), the Plaintiff makes a monetary claim in respect of an alleged debt with an amount of HK\$101,986,276.07 against the said 1st Defendant and the Company. The writ of summons was served on the Company on about 25 February 2026 from the solicitors acting for the Plaintiff.

As at the date of this announcement, the Company is in the course of seeking legal advice on the Proceedings, including the validity and quantum of the Plaintiff’s claim, and will take appropriate steps to safeguard the interests of the Company and its shareholders.

Given that the Proceedings are at an early stage, their outcome is uncertain and may or may not have a material impact on the financial position and operations of the Group. The Company will closely monitor the development of the Proceedings and will make further announcement(s) as and when appropriate and in accordance with the requirements of the Listing Rules to keep its shareholders and potential investors informed of any material developments.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
